

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.redbarnsaintbernards.com>, and Pure Love Puppies LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Pure Love Puppies LLC include <https://www.redbarnsaintbernards.com>, Red Barn Saint Bernards and <https://www.redbarnsaintbernards.com>. The Pure Love Puppies LLC website is a Puppy Breeder site. By using the Pure Love Puppies LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Pure Love Puppies LLC may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

If you purchase Pure Love Puppies LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Pure Love Puppies LLC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. Use of your Personal Information

Pure Love Puppies LLC collects and uses your personal information to operate and deliver the services you have requested.

Pure Love Puppies LLC may also use your personally identifiable information to inform you of other products or services available from Pure Love Puppies LLC and its affiliates.

Sharing Information with Third Parties

Pure Love Puppies LLC does not sell, rent or lease its customer lists to third parties.

Pure Love Puppies LLC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Tracking User Behavior

Automatically Collected Information

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

Pure Love Puppies LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
